ENVIRONMENT MANAGEMENT SYSTEM

According to valid Certificate EN ISO 14001:2015 SK12/1814

- to keep the specific PTW production below 140 kg per a tonne of production /PTW = plastic technological waste/
- to keep the amount of total landfilled waste out of the total material waste at 10%
- to keep the ratio of PTW recovered materially, energetically and by recycling, to the landfilled waste amount at the level of 99:1

ENERGY MANAGEMENT SYSTEM
